Introducing Section 17A of the MACC Act

The new Section 17A not only establishes a new statutory corporate liability offence of corruption by a commercial organisation under Malaysian law, but also deems any director, controller, officer, partner or manager to be personally liable for the same offence if the commercial organisation is found liable. The topic has far-reaching implications for the construction industry, specifically on the bosses.
